(Telangana State Engineering, Agriculture and Medical Common Entrance Test) (being conducted on behalf of TSCHE)

1. Entrance Test:

Telangana State Engineering, Agriculture and Medical Common Entrance Test 2019 (TS EAMCET 2019) will be conducted (as per G.O. Ms.No. 73 Higher Education EC.2 Dept., Dt: 28-07-2011, G.O.Ms.No.33 of Higher Education (TE/A2) Department dated 31-12-2014) by Jawaharlal Nehru Technological University Hyderabad (JNTUH) for entry into the first year of the following Under Graduate Professional courses offered for the academic year 2019-20 in the Universities & Private unaided and affiliated Professional colleges in the State of Telangana.

- a. B.E., B.Tech. / B.Tech. (Bio-Tech.) / B.Tech. (Diary Technology) / B.Tech. (Ag. Engineering) / B. Pharmacy / B.Tech. (Food Technology (FT)) / B.Sc. (Hons.) Agriculture / B.Sc. (Hons.) Horticulture / B.Sc.(Forestry) / B.V.Sc. & A.H. / B.F.Sc.
- b. Pharm-D.

Eligibility Criteria to appear for TS EAMCET 2019:

Candidates satisfying the following requirements shall be eligible to appear for TS EAMCET 2019:

- Candidates should be of Indian Nationality or Persons of Indian Origin (PIO) / Overseas Citizen of India (OCI) Card Holders.
- Candidates should belong to the state of Telangana / Andhra Pradesh. The candidates should satisfy local / non - local status requirements as laid down in the Telangana / Andhra Pradesh Education Institutions (Regulations of Admission) order, 1974 as subsequently amended.
- For BE / B.Tech in Engineering, Bio- Technology, B.Tech (Dairy Technology), B.Tech (Ag. Engineering) and for 50% seats in B. Pharmacy, B. Tech (Food Technology (FT)) Courses:
 - (i) Candidates should have passed or appeared for the final year of Intermediate Examination (10+2 pattern) with Mathematics, Physics along with Chemistry / Biotechnology / Biology as optionals or related vocational courses in the fields of Engineering and Technology, conducted by the Board of Intermediate Education, Telangana / Andhra Pradesh along with bridge course or courses conducted by it for candidates enrolled during 2000-2002 and subsequent batches, or any other examination recognized as equivalent thereto by the Board of Intermediate Education, Telangana / Andhra Pradesh, provided that candidates who have passed or appeared for the final year of Intermediate Examination (10+2 pattern) with Biology, Physics and Chemistry as optionals along with the bridge course examination in Mathematics conducted by the Board of Intermediate Education, Telangana / Andhra Pradesh shall also be eligible for the Bio-Technology course.

(OR)

Candidates should have passed or appeared at the final year of the Diploma examination in Engineering conducted by the State Board of Technical Education and Training, Telangana / Andhra Pradesh or any other examination recognized as equivalent thereto by the State Board of Technical Education and Training, Telangana / A.P.

(ii) Candidate should obtain at least 45% of marks (40% in case of candidates belonging to reserved category) in the subjects specified taken together at 10+2 pattern.

(iii) In the case of Engineering and Pharmacy courses, candidates should have completed 16 years of age, as on 31st December of the year of admission. There is no upper age limit.

(iv) In the case of B.Tech (Dairy Technology), B.Tech. (Ag. Engineering), B.Tech. (FT), Candidates should have completed 17 years of age as on 31st December of the year of admission and an upper age limit of 22 years for all the candidates and 25 years in respect of Scheduled Caste and Scheduled Tribe candidates as on 31st December of the year of Admissions.

d) For B.Sc. (Hons.) Agriculture / B.Sc. (Hons.) Horticulture/ B.Sc. (Forestry) / B.V.Sc. & A.H. / B.F.Sc. and for remaining 50% seats in B.Tech. (FT) Courses:

Candidates should have passed or appeared for the final year of Intermediate Examination (10+2 pattern) or any examination recognized as equivalent thereto by the Board of Intermediate Education, Telangana / Andhra Pradesh with any two / three of the subjects indicated against each course noted below: With any two of the subjects:

(i) B.Sc. (Hons.) Agriculture

(i) Physical Sciences

(ii) Biological or Natural Sciences

(iii) Agriculture

(iv) Vocational Course in Agriculture

(ii) B.Sc. (Hons.) Horticulture

(i) Physical Sciences

(iii) Agriculture

(iv) Vocational Course in Agriculture

(iii) B.Sc. (Forestry)

(i) Physics (ii) Chemistry

(iii) Biology

or

(i) Mathematics

(ii) Biological or Natural Sciences

(v) B.F.Sc.

(i) Physical Sciences

(ii) Biological or Natural Sciences

- Note: (1) Irrespective of the subjects taken at the qualifying examination, candidates seeking admission to the above courses in section 2(d) should appear for Biology, Physics and Chemistry in TS EAMCET 2019.
 - (2) Candidates should have completed 17 years of age as on 31st December of the year of admission and an upper age limit of 22 years for all the candidates and 25 years in respect of scheduled caste and scheduled tribe candidates as on 31st December of the year of Admissions.

e) For B.Pharmacy Course: (Remaining 50% of the seats):

- (i) Candidates should have passed or appeared for the final year of the Intermediate Examination (10+2 pattern) with Physics, Chemistry and Biology optionals, conducted by the Board of Intermediate Education, Telangana / Andhra Pradesh or any other examination recognized by the University as equivalent thereto.
- (ii) Candidate should obtain at least 45% marks (40% in case of candidate belonging to reserved category) in the subjects specified taken together in the qualifying examination.
- (iii) Candidates should have completed 16 years of Age by the date of commencement of Admissions or on such other date as may be notified by the CET Committee. There is no upper age limit.

f) For Pharm -D Course (50% seats for M.P.C and 50% seats for Bi.P.C candidates):

(i) Candidates should have passed or appeared for the final year of Intermediate examination (10+2 pattern) with Physics, Chemistry and Mathematics or Biology optionals conducted by the Board of Intermediate Education, Telangana / Andhra Pradesh or any other examination recognized by the

Telangana / Andhra Pradesh State Board of Technical Education and Training or any other examination recognized as equivalent thereto by the Telangana / Andhra Pradesh State Board of Technical Education and Training.

(ii) Candidate should obtain at least 45% marks (40% in case of candidate belonging to reserved category) in the subjects specified taken together in the qualifying examination.

(iii) Candidate should have completed 17 years of age as on 31st December of the year of admission to the course.

3. Proof of satisfying the marks criteria in respect of candidates who appeared for the Qualifying examination (10+2) during the year should be furnished within 7 days after publication of the examination results by the concerned examination Board.

4. NORMALIZATION OF QUESTION PAPER:

TS EAMCET 2019 is being conducted in multiple sessions based on the same syllabus, same pattern for candidates having same eligibility criteria. A candidate will be eligible to appear only in one session. Since the question paper is different for each session, there is a possibility that the candidates may compare themselves about the variation in the difficulty levels of question paper of the same subject. However, it may be noted that utmost care will be taken so that all the subjects are of the same standard. Further, it is decided to adopt a normalization process to eliminate any such variations in the difficulty levels of various sessions.

The main aim of the Normalization is to ensure that no student gets advantage/disadvantage due to multiple sessions. The normalization process brings all the candidates across all sessions on a comparative scale. Due to this process, the marks of the easy session may be reduced marginally and marks of hard session may increase marginally on the global scale. This depends exactly on the average performance in each session. Since care is taken to prepare papers of equal difficulty, these changes are expected to be very marginal. Normalized marks justify the candidates while respecting their actual performance. Hence, the following normalization procedure is adopted which is being followed by other competitive Examinations in India to avoid advantage/disadvantage to candidates in a particular session compared to the other sessions.

Normalized marks of the candidate

= $GASD + \frac{(GTA-GASD)}{(STA-SASD)}x(Marks obtained by the candidate in the subject in a session - SASD)$

Where,

SASD: Sum of Average (A) and Standard Deviation (SD) of the subject of a session in which the candidate appeared.

GASD: Sum of Average (A) and Standard Deviation (SD) of all the candidates across all sessions of the subject put together.

STA: Average mark of the top 0.1% of the candidates in the subject of a session in which the candidate appeared.

GTA: Average mark of the top 0.1% of all the candidates across all the sessions of the subject put together.

Note: For the candidates for whom there is no qualifying cut-off in TS EAMCET 2019, if the marks in TS EAMCET 2019 after normalization go below zero (negative), the mark is treated as zero. If the tie persists, then TS EAMCET 2019 normalization marks (though negative) are considered for resolving the tie.

- 5. Criteria for Ranking: The candidates who have secured qualifying marks (Normalized marks) in TS EAMCET 2019 and candidates belonging to the category of Scheduled Caste and Schedule Tribe, for whom qualifying marks have not been prescribed, shall be assigned ranking in the order of merit on the basis of combined score obtained by giving 75% weightage to the Normalized marks secured in TS EAMCET 2019 and 25% weightage to the marks secured in the relevant group subjects namely Mathematics or Biology, Physics, Chemistry of the qualifying examination.
- 6. Submission of the Online Application form for Engineering (E) and Agriculture and Medical (AM) streams:

Candidates with Mathematics, Physics, Chemistry / Bio-Tech. / Biology as optional subjects in their Intermediate or its equivalent course should submit "E" stream online application for Engineering B.E./B.Tech. / B.Tech. (Ag. Engg.) / B.Tech.(Dairy Technology) / B.Tech.(FT) / B.Pharm. (MPC) / Pharm-D (MPC) courses.

Candidates with Biology, Physics and Chemistry as optional subjects in their Intermediate or its equivalent course should submit "AM" stream online application for B.Sc. (Hons.) Agriculture / B.Sc. (Hons.)

(Bi.P.C.) / Pharm-D (Bi.P.C) courses. For B.Tech. (Bio-Technology) (Bi.P.C), candidates shall pass / appear for Bridge Course exam in Mathematics conducted by B.I.E., A.P./ T.S. as per G.O. 17, Dt. 2-2-08.

8. Criteria for Admissions:

- i. As per the Gazette of India: Extraordinary under Part-III Rule No. 7(2) for admission into B.V.Sc. & AH Courses on the basis of competitive entrance examination, a candidate under General Category for admission to this course must have obtained 50% marks in English, Physics, Chemistry and Biology in their qualifying examination. In respect of candidates belongs to the Scheduled Caste / Scheduled Tribe or other special category of student as specified by the Government from time to time, marks required for admission shall be 10% less than that prescribed for general category.
- As per G.O. Ms. No. 73,74 & 75 dated 28-07-2011, the candidate shall fulfill eligibility criteria for admission into Engineering, Pharmacy and Pharm-D courses.
- iii. G.O.Ms.No.5, H.E.(TE) Dept, dt.23.02.2018
- iv. However, in all the cases, candidate shall fulfill the eligibility criteria as laid down in the relevant G.Os/Amendments/Notifications to be issued at the time of Admissions.
- How to submit Application Form: TS EAMCET 2019 application should be submitted through ONLINE mode only.

TS ECET-2019 DETAILED NOTIFICATION



(TS ECET [(FDH & B.Sc. (Mathematics)] – 2019) (being conducted on behalf of TSCHE)

Entrance Test:

A Common Entrance Test designated in full as Telangana State Engineering Common Entrance Test for Diploma Holders of Engineering/Technology/Pharmacy and for B.Sc.(Mathematics) Holders and in short as TS ECET [FDH & B.Sc.(Mathematics)]-2019 will be conducted by JNT University Hyderabad on behalf of the Telangana State Council of Higher Education for the academic year 2019-20 in accordance with G.O.Ms.No.: 24 Education (EC) Department dated:18.03.2004, G.O. Ms. No: 25, dated:28.06.2006 and G.O.Ms.No.:19, dated: 02.02.2008 for Diploma Holders and G.O. Ms. No. 57 (EC2) dated:12.05.2008 & G.O. Ms. No. 58 (EC2) dated:12.05.2008 for B.Sc.(Mathematics) degree holders, G.O.Ms. No. 49 dated 04-06-2011 & G.O.Ms. No. 15(EC) dated 18.8.2014

- For lateral admission into 2nd year regular B.E. / B.Tech. Courses in both University and Unaided Private Professional Institutions (Minority & Non-Minority) approved by All India Council for Technical Education and
- (ii) For lateral admission into 2nd year regular B. Pharm. Course in both University and private Unaided professional institutions (Minority & Non-Minority) approved by Pharmacy Council of India.

Note: B.Sc. (Mathematics) Degree holders are not eligible for admission into B.Pharmacy course.

The GOs issued earlier to conduct TS ECET before the state bifurcation are adapted to conduct TS ECET-2019 by the government of Telangana State according to G.O. Ms. 33 dated 31.12.2014.

Eligibility Criteria to appear for TS ECET-2019:

Candidates should satisfy the following requirements to be eligible for appearing at the TS ECET [FDH & B.Sc. (Mathematics)]-2019.

- They should be of Indian Nationality.
- (ii) They should belong to the State of Telangana / Andhra Pradesh. The candidates should satisfy local/nonlocal status requirements as laid down in the Andhra Pradesh Educational Institutions (Regulation of Admission) Order, 1974 as subsequently amended. The same is adapted to the state of Telangana G.O.Ms.33 dated 31.12.2014.
- (iii) They should have obtained a Diploma in Engineering and Technology / Pharmacy from the State Board of Technical Education of Telangana / Andhra Pradesh or any other Diploma recognized by the Government of Telangana/ Andhra Pradesh as equivalent there to for admission into the relevant B.E. / B. Tech./ B. Pharmacy Courses corresponding to the Diplomas as given in the Annexure (see in Instruction Booklet).

(OR)

They should have passed the 3-year B.Sc. Degree examination with Mathematics as one of the subjects in the group combination from a recognized University in the Telangana/Andhra Pradesh state or its equivalent for entry into relevant courses as given in the Annexure.

- (iv) Candidates who are pursuing a Diploma course under sandwich pattern shall be eligible for entry into the relevant B.E./ B.Tech./ B.Pharmacy courses provided they have completed the practical training for the sandwich course before close of counseling for entry into the relevant course.
- (v) Candidates should have passed Diploma in Engineering and Technology / Pharmacy/ B.Sc (Mathematics) Degree as the case may be with at least 45% marks (40% in case of candidates belonging to reserved category) for entry into relevant courses.

3. Eligibility for admission into B.E./B.Tech./B.Pharm.:

- (i) For lateral admission into 2nd year regular B.E. / B.Tech. Courses in both University and Un-Aided Private Professional institutions (Minority & non-Minority) approved by All India Council for Technical Education and
- (ii) For lateral admission into 2nd year regular B. Pharmacy Course in both University and private Un- Aided professional institutions (Minority & Non-Minority) approved by Pharmacy Council of India.

Candidates should have appeared and qualified at the TS ECET-2019. Mere appearance at the Entrance Test does not automatically entitle a candidate to be considered for entry into any course unless the candidate satisfies the requirement of eligibility and other criteria laid down in the rules of admission.

Admission to 85% of the seats in each course shall be reserved for the local candidates and the remaining 15% of the seats shall be un-reserved seats as specified in the Andhra Pradesh Educational Institutions (Regulations and Admissions) Order, 1974 as subsequently amended. The same is adapted to the state of Telangana G.O. Ms. No. 33 dated 31.12.2014.

(iii) Qualifying marks in TS ECET [FDH & B.Sc. (Mathematics)]-2019.

The qualifying percentage marks for obtaining a rank in TS ECET [FDH & B.Sc.(Mathematics)]-2019 is 25% of the aggregate marks in the four subjects [Three subjects for B.Sc. (Mathematics)], i.e., 50 marks out of a total of 200. However, in the case of SC/ST candidates, there shall be no minimum qualifying marks for ranking the candidates. The rank obtained with the benefit of relaxation of the minimum qualifying marks at the TS ECET [FDH & B.Sc.(Mathematics)]-2019 by any candidate claiming to belong to SC/ST category will be cancelled in case the claim is found to be invalid at the time of admission.

4. Evaluation and ranking in TS ECET [FDH & B.Sc.(Mathematics)]-2019:

- (i) The student will be ranked (Integrated Merit Rank) based on the marks obtained by him/her in the TS ECET [FDH & B.Sc. (Mathematics)]-2019 Examination.
- (ii) Every care will be taken to avoid errors in valuation, checking, scrutiny, tabulation and ranking. Hence, request for re-totaling, revaluation or personal identification of anything related to Online Examination will in no case be entertained. Candidates will be ranked in the order of merit in TS ECET [FDH & B.Sc.(Mathematics)]-2019 separately in each branch of Engineering Course.
- (iii) As per G.O. Ms. No. 58 dated 12-05-2008, for admission into B.E. / B.Tech in Information Technology, first preference will be given to candidates who have obtained the diploma in Information Technology. Any seats still vacant shall be filled with candidates who have obtained their Diploma in any branch of Engineering / Technology on the basis of their integrated merit ranking obtained in TS ECET [FDH & B.Sc.(Mathematics)]-2019.
- (iv) As per G.O. Ms. No. 58 dated 12-05-2008, for admission into B.E / B.Tech in Computer Science and Engineering, first preference will be given to candidates who have obtained the diploma in Computer Science Engineering. Any seats still vacant shall be filled with candidates who have obtained their Diploma in any branch of Engineering/ Technology basis on the of their integrated merit TS ECET [FDH & B.Sc.(Mathematics)]-2019.

The Integrated Merit Rank is based on the total marks obtained in TS ECET [FDH & B.Sc. (Mathematics)]-2019 by candidates with Diploma in any branch of Engineering/Technology.

(v) (a) Engineering:

In case of a tie in aggregate, the marks obtained in Engineering subject, and in case of further tie the marks obtained in the Mathematics subject and if the tie still continues, the marks obtained in physics subject will be taken into account to decide the relative ranking. In case of candidates getting equal marks in each of the four subjects, they will be bracketed

for the purpose of award of rank. Age of the candidate will be considered at the time of admission for resolving the tie, the older candidate being given preference.

(b) Pharmacy:

Candidates will be ranked on the basis of merit in TS ECET [FDH & B.Sc.(Mathematics)]-2019. In case of tie the percentage of marks secured in the qualifying examination will be taken into consideration. On further tie, age will be taken into consideration; the older candidate will be given priority at the time of admission.

(c) B.Sc.(Mathematics):

Candidates will be ranked based on the marks obtained in the entrance examinations. In case of a tie in aggregate, the marks obtained in Mathematics subject and in case of further tie the aggregate marks obtained in the qualifying examination shall be taken into account to resolve the tie at the time of admission. On further tie, age will be taken into consideration; the older candidate will be given priority at the time of admission.

- (vi) The rank cards can be downloaded from website https://ecet.tsche.ac.in as per the schedule.
- 5. Submission of Application form for TS ECET [FDH & B.Sc.(Mathematics)]-2019 is through ONLINE Mode only.
- 6. Detailed information regarding Syllabi, Procedure for Online Application etc., is given in the "Instruction Booklet", displayed in the website https://ecet.tsche.ac.in.
- 7. Criteria for Admissions:

The following order of preference shall be observed in considering Diploma Holders for admission into various courses:

- i) For admission into Degree programme in Information Technology, first preference will be given to candidates who have obtained the Diploma in Information Technology. Any seats still vacant shall be filled with candidates who have obtained their Diploma in any branch of Engineering / Technology on the basis of their integrated merit ranking.
- ii) For admission into Degree programme in Textile Technology, candidates who have obtained their Diploma in Textile Technology (Design & Manufacturing) and Textile Technology (Knitting) must necessarily have completed their Intermediate or equivalent with Mathematics, Physics and Chemistry as compulsory subjects.
- iii) For admission into Degree programme in Bio-Technology, first preference will be given to candidates who have obtained the Diploma in Bio-Technology. Any seats still vacant shall be filled with candidates who have obtained their Diploma in Pharmacy or Chemical Engineering in the ratio of 1:1 respectively.
- iv) Diploma Holders of Special Diploma course in Industrial Electronics & Instrumentation Engineering/ Electronics & Instrumentation Engineering have to appear for TS ECET FDH Examination in Electronics & Instrumentation Engineering only (EIE) for admission into Instrumentation Engineering (IE) / Electronics & Instrumentation Engineering (EIE) / Applied Electronics & Instrumentation Engineering Courses.

However, in all the cases, candidate shall fulfill the eligibility criteria as laid down in the relevant G.O.s/ Amendments/ Notifications to be issued at the time of Admissions.

Letter from Government of Telangana & Rule of Reservation for Admission as per the Presidential Order 1974

Seats will be reserved, to the following categories in Admissions to Professional Courses:

 Reservation in State-wide Universities (as per Presidential Order 371 Article D in consonance to Section 95 of the A.P. Reorganization Act, 2014 (Lr. No: 1959/TE/A2/2015-2, dated 29-04-2015):

The admissions to 85% of the total available seats shall be reserved for the Local Candidates (Osmania University area, TS) and the remaining 15% of the seats shall be un-reserved (these seats can be filled with both States Telangana and Andhra Pradesh students based on merit) as specified in the Presidential Order 371 Article D in consonance to Section 95 of the A.P. Reorganization Act, 2014.

(A) Local Areas Means:

i. The part of the State comprising the districts of Adliabad, Bhadradri Kothagudem, Hyderabad, Jagtial, Jangaon, Jayashankar Bhoopalpally, Jogulamba Gadwal, Kamareddy, Karimnagar, Khammam, Komaram Bheem Asifabad, Mahabubabad, Mahbubnagar, Mancherial, Medak, Medchal , Nagarkurnool, Nalgonda, Nirmal, Nizamabad, Peddapalli, Rajanna Sircilla, Ranga Reddy, Sangareddy, Siddipet , Suryapet, Vikarabad, Wanaparthy, Warangal (Rural), Warangal (Urban) and Yadadri Bhuvanagiri shall be regarded as the Local Area for the purpose of admission to the Osmania University, the Kakatiya University, Telangana University, Mahatma Gandhi University, Palamuru University and to any other educational institutions (other than a state-wide university or state-wide educational institution) which is subject to the control of the State Government and situated in that part.

(B). Local Candidate means:

- 1. A candidate for admission shall be regarded as a Local Candidate in relation to a local area (Osmaina University Area, Telangana State).
 - 1.1 If he/she has studied in an educational Institution or educational institutions in such local area for a period of not less than four consecutive academic years ending with the academic year in which he/she appeared or first appeared in the relevant qualifying examination, as the case may be, (see Annexure II) or
 - 1.2 Where, during the whole or any part of the four consecutive academic years ending with the academic year in which he/she appeared or, as the case may be, first appeared for the relevant qualifying examination, he/she has not studied in

any educational Institutions, if he/she has resided in that local area for a period of not less than four years immediately preceding the date of commencement of the relevant qualifying examination in which he/she appeared or first appeared, as the case may be (see Annexure - III).

- 2. A candidate for admission to the Course who is not regarded as local candidate under clause (A) above, in relation to any local area shall,-
 - 2.1 If he/she has studied in educational Institutions in the State for a period of not less than seven consecutive academic years ending with the academic year in which he/she appeared or first appeared for the relevant qualifying examination, as the case may be, be regarded as a local candidate in relation to,-
 - (i) Such local area where he/she has studied for the maximum period out of said period of seven years, or
 - (ii) Where the period of his/her study in two or more local areas is equal, such local area, where he/she has studied last in such equal periods. (see Annexure II)
 - 2.2 If, during the whole or any part of seven consecutive academic

years ending with the academic year in which he/she appeared or first appeared for the relevant qualifying examination, as the case may be, he/she has not studied in the educational institutions in any local area, but has resided in the state during the whole of the said period of seven years, be regarded as a local candidate in relation to,-

- (i) Such local area where he/she has resided for the maximum period out of the said period of seven years, or
- (ii) Where the period of his/her residences in two or more local areas are equal, such local area where he/she has resided last in such equal periods. (see Annexure III)

(C). The Non-Local Candidate means

- Candidates coming under any of the categories given below and not satisfying the conditions mentioned in 1 or 2 above are treated as Non-Local to Osmania University Area
 - (a) candidates who have resided in Telangana and Andhra Pradesh States for a total period of 10 years excluding periods of study outside in Telangana and Andhra Pradesh States (see Annexure IV) or
 - (b) Candidate's either of whose parents have resided in Telangana and Andhra Pradesh States for a total period of ten years excluding the period of employment outside in Telangana and Andhra Pradesh States(see Annexure IV) or

- (c) Candidates who are children of parents who are in the employment of in Telangana and Andhra Pradesh States or Central Government, Public Sector Corporations, Local Bodies, Universities and other similar quasi-public institutions, within the state, at the time of submitting the application (see Annexure IV) or
- (d) Candidates who are spouses of those in the employment of the state or Central Government, Public Corporations, Local Bodies, Universities and Educational Institutions recognized by the Government or University OR other competent authority and similar quasi Government Institutions within in Telangana and Andhra Pradesh States, at the time of submitting the application (see Annexure IV).
- If a local candidate in respect of a local area is not available to fill any seat reserved or allocated in favour of a local candidate in respect of that local area, such seat shall be filled if it had not been reserved.
- 4. Candidates who claim reservation under any of the categories mentioned above shall enclose copies of relevant certificates. The respective proformas are available in the Annexure -2.

NOTE: For details, see the Andhra Pradesh Educational Institutions (Regulations of Admission) Order, 1974 as subsequently amended (G.O.No.646. dated 10.7.1979).

2. Reservation for SC/ST/BC Communities:

(See Annexure - V)

- (a) 15% of seats shall be reserved for the candidates belonging to scheduled Castes.
- (b) 6% of seats shall be reserved for the candidates belonging to the scheduled Tribes.

The seats reserved for scheduled Tribes shall be made available to scheduled Castes and Vice-versa, if qualified candidates are not available in the category. If qualified candidate belonging to Scheduled Castes and Scheduled Tribes communities are not available the left over seats reserved for them shall be treated as unreserved seats and shall be filled by candidates of General Pool.

(c) 25% of seats shall be reserved for the candidates belonging to the Backward Classes and shall be allocated among the following groups of Backward Classes as shown below:

If qualified candidates belonging to Backward Class of a particular group are not available, the leftover seats can be adjusted for the candidates of next group. If qualified candidates belonging to Backward Classes are not available to fill up the

25% seats reserved for them, the left over seats shall be treated as unreserved and shall be filled up with candidates of General Pool.

No candidates seeking reservation for admission under above categories be allowed to participate, in the Counseling for admission unless he/she produces the integrated Community Certificate prescribed by the Govt. and issued by the Revenue Authorities in the Government (vide G.O. MS. No: 58, Social Welfare (J), Dept., Dated: 12-5-1997)

III. Reservation of seats for women:

A (horizontal) reservation of 33 1/3 % of seats in favor of women candidates in each category (OC/SC/ST/BC/Special Categories) shall be followed.

The above reservation shall not be applicable if women candidates selected on merit in each category exceed 33 1/3%. If sufficient number of women candidates are not available in the respective categories those seats shall be diverted to the men candidates of the same category.

IV. Reservation for Special Categories:

(See Annexures - VII & VIII)

- (a) Seats shall also be reserved for the following categories, to the extent indicated against them,
 - Physically Handicapped (PH) there shall be 3% (three percent) horizontal reservation in each category (OC, BC, SC, ST) for Visually handicapped/ hearing impaired/ Orthopedically Handicapped (each 1%) (One percent).
 - ii. Children of Armed Forces Personnel (CAP) -2% (two percent) for the children of armed persons i.e. Ex-Servicemen, Defense Personnel including the Children of Border Security Force and the Central Reserve Police Force residing in Telangana for a minimum period of 5 years.
 - National Cadet Corps (NCC) 1% (one percent) horizontal reservation for National Cadet Corps candidates.
 - iv. Sports and Games (SP) $\frac{1}{2}$ % (half percent) horizontal reservation for sports and Games candidates.

If qualified candidates belonging to PH/CAP/NCC/SP/ Categories are not available, the left over seats shall be filled up with candidates of General Pool of the same local area.

Note: The candidates claiming reservation benefits under the above categories shall produce original documents in support of their claim to the Convener of Admissions and he shall be entitled to get them scrutinized/verified and also refer the original document of the candidates claiming reservation for scrutiny and confirmation, to the following authorities.

(i) PH - Director, Medical & Health Services, Telangana
(ii) CAP - Director, Sainik Welfare Board, Telangana/A.P.

(iii) NCC - Director of NCC, Telangana/A P

(iv) Sports & Games - Vice-Chairman and Managing Director, Sports Authority of Telangana/A.P. (SAAP)

The priorities in respect of the special categories mentioned above shall be in accordance with Government Orders issued from time to time.

RESERVATION POLICY IN ANDHRA PRADESH IN ADMISSIONS INTO B.TECH, M.TECH, MBA AND MCA

As per Andhra Pradesh Government rules and regulations, 61% of the total seats in B.Tech, M.Tech, MBA and MCA are reserved for Scheduled Castes, Scheduled Tribes, Backward Classes, PH, NCC, Sports, Extra Circular Activities, Ex-service men, defense personnel residing in either of the two states. Remaining 39% of these seats are reserved for Open Category as well as for above said castes. The Category wise reservation is as follows as per rules enforced.

S.No	Category	Seats to be reserved
1	Schedule castes	15%
2	Schedule tribes	6%
3	Backward classes	29%(BC-A: 7%, BC-B: 10%, BC-C: BC-D: 7% & BC-E:4%)
4	Physically handicapped	3%
5	NCC, Sports & Extra curricular activities	5%
6	Ex-service men & defence personnel residing in the State	3%

33.33% or 1/3rd of total seats have to be reserved for girls category wise where there are no separate colleges for them.

However the student has to get minimum cut off marks in EAMCET test for B.Tech admission, ICET test for MBA and MCA admissions and PG SET test for M.Tech.

ADMISSION POLICY FOR ADMISSION IN TO B.TECH, M.TECH, MBA AND MCA

- 1. AP EAMCET is an entrance examination held for admissions into various undergraduate professional courses offered at universities and colleges in Andhra Pradesh. These are called category A seats. The selection procedure for this exam is done after results of the examination are declared by JNTU. This process is known as counselling, which is usually scheduled in the month of June. Candidates will be called for counselling as per the rank obtained in the entrance exam AND 70% of the seats are filled through EAMCET counselling. The EAMCET qualified candidates will be allotted seats based on their merit, category, gender, local area, and importantly availability of seats.
- 2. Management Quota: The colleges can fill 30% seats can be filled under the management and NRI quota. These are called category B seats. The following is the procedure to fill the seats.
 - a. Notifications' have to be brought out by all the managements of the non minority private colleges of Engineering and Technology, in at least two leading newspapers.
 - b. The notifications must invite applications both in the physical format as well as on-line for admission to category-B seats.
 - c. The physical format of the proforma application shall be put up by the respective colleges on its notice board
 - d. It should also be sent to the university to which it is affiliated.
 - e. The proforma application forms must also be submitted to the A.P.State Council of Higher Education which will also put up the same on the

- notice board and website for students to easily access them to submit after duly filling in.
- f. Candidates must send the duly filled in applications as specified by registered post with acknowledgement thereto.
- g. The colleges shall consider the received applications and prepare a merit list in the descending order of the applicants.
- h. The Merit List must be displayed on the notice board as well as the website of the respective colleges for two weeks.
- It should be made available for the scrutiny of the
 Convener (Admissions), EAMCET- 2013.
- j. Admissions will also be as per the Merit List in the descending order of the applicants
- The colleges have to obtain ratification from the Competent Authority for all the admissions conducted under category-B seats
- Tuition fees shall be charged as prescribed by AFRC for category-B seats

Annexure - 1

Rule of Reservation for Admission

Seats will be reserved, to the following categories in Admissions to Professional Courses:

1. Reservation in State-wide Universities (as per Presidential Order 371 Article D in consonance to Section 95 of the A.P. Reorganization Act, 2014:

The admissions to 85% of the total available seats shall be reserved for the Local Candidates (Andhra Pradesh) and the remaining 15% of the seats are open to Andhra Pradesh and Telangana students based on merit, as specified in the Presidential Order 371 Article D in consonance to Section 95 of the A.P. Reorganization Act, 2014.

(A) Local Areas Means:

- i. The part of the State comprising the districts of Srikakulam, Vizianagaram, Visakhapatnam, East Godavari, West Godavari, Krishna, Guntur and Prakasam shall be regarded as the Local Area for the purpose of admission to Andhra University, the Acharya Nagarjuna University and Adikavi Nannaya University and to any other educational institutions (other than a state-wide university or state-wide educational institution) which is subject to the control of the State Government and s situated in that part.
- ii. The part of the State comprising the districts of Anantapur, Kurnool, Chittoor, Kadapa and Nellore shall be regarded as the Local Area for the purpose of admission to the Sri Venkateswara University, the Sri Krishnadevaraya University and the Yogi Vemana University and to any other educational institutions (other than a state-wide university or state-wide educational institution) which is subject to the control of the State Government and situated in that part.

(B). Local Candidate means:

- 1. A candidate for admission shall be regarded as a Local Candidate in relation to a local area (AU/SVU, AP),-
 - 1.1 If he/she has studied in an educational Institution or educational institutions in such local area for a period of not less than four consecutive academic years ending with the academic year in which he/she appeared or first appeared in the relevant qualifying examination, as the case may be, or

- 1.2 Where, during the whole or any part of the four consecutive academic years ending with the academic year in which he/she appeared or, as the case may be, first appeared for the relevant qualifying examination, he/she has not studied in any educational Institutions, if he/she has resided in that local area for a period of not less than four years immediately preceding the date of commencement of the relevant qualifying examination in which he/she appeared or first appeared, as the case may be .
- 2. A candidate for admission to the Course who is not regarded as local candidate under clause (A) above, in relation to any local area shall,-
 - 2.1 If he/she has studied in educational Institutions in the State for a period of not less than seven consecutive academic years ending with the academic year in which he/she appeared or first appeared for the relevant qualifying examination, as the case may be, be regarded as a local candidate in relation to,-
 - (i) Such local area where he/she has studied for the maximum period out of said period of seven years, or
 - (ii) Where the period of his/her study in two or more local areas is equal, such local area, where he/she has studied last in such equal periods. (see Annexure II)
 - 2.2 If, during the whole or any part of seven consecutive academic

years ending with the academic year in which he/she appeared or first appeared for the relevant qualifying examination, as the case may be,he/she has not studied in the educational institutions in any local area, but has resided in the state during the whole of the said period of seven years, be regarded as a local candidate in relation to,-

- (i) Such local area where he/she has resided for the maximum period out of the said period of seven years, **or**
- (ii) Where the period of his/her residences in two or more local areas are equal, such local area where he/she has resided last in such equal periods. (see Annexure II)

(C). The Non-Local Candidate means

- Candidates coming under any of the categories given below and not satisfying the conditions mentioned in 1 or 2 above are treated as Non-Local to Andhra and S V University areas.
 - (a) candidates who have resided in the state of A P/ Telangana for a total period of 10 years excluding periods of study outside A P/ Telangana (see Annexure III) or

- (b) Candidate's either of whose parents have resided in A P/ Telangana for a total period of ten years excluding the period of employment outside A P/ Telangana (see Annexure III) or
- (c) Candidates who are children of parents who are in the employment of A P/
 Telangana or Central Government, Public Sector Corporations, Local Bodies,
 Universities and other similar quasi-public institutions, within the state, at the time
 of submitting the application (see Annexure III) or
- (d) Candidates who are spouses of those in the employment of A P/ Telangana or Central Government, Public Corporations, Local Bodies, Universities and Educational Institutions recognized by the Government or University or other competent authority and similar quasi Government Institutions within A P/ Telangana, at the time of submitting the application (see Annexure III).
- 3. If a local candidate in respect of a local area is not available to fill any seat reserved or allocated in favour of a local candidate in respect of that local area, such seat shall be filled if it had not been reserved.
- 4. Candidates who claim reservation under any of the categories mentioned above shall enclose copies of relevant certificates. The respective proformas are available in the Annexure -2-7.

NOTE: For details, see the Andhra Pradesh Educational Institutions (Regulations of Admission) Order, 1974 as subsequently amended (G.O.No.646. dated 10.7.1979).

2. Reservation for SC/ST/BC Communities:

(See Annexure - IV)

- (a) 15% of seats shall be reserved for the candidates belonging to scheduled Castes.
- (b) 6% of seats shall be reserved for the candidates belonging to the scheduled Tribes.

The seats reserved for scheduled Tribes shall be made available to scheduled Castes and Vice-versa, if qualified candidates are not available in the category. If qualified candidate belonging to Scheduled Castes and Scheduled Tribes communities are not available the left over seats reserved for them shall be treated as unreserved seats and shall be filled by candidates of General Pool.

(c) 25% of seats shall be reserved for the candidates belonging to the Backward Classes and shall be allocated among the following groups of Backward Classes as shown below:

If qualified candidates belonging to Backward Class of a particular group are not available, the leftover seats can be adjusted for the candidates of next group. If qualified candidates belonging to Backward Classes are not available to fill up the 25% seats reserved for them, the left over seats shall be treated as unreserved and shall be filled up with candidates of General Pool.

No candidates seeking reservation for admission under above categories be allowed to participate, in the Counseling for admission unless he/she produces the Integrated Community Certificated prescribed by the Govt. and issued by the Revenue Authorities in the Government (vide G.O. MS. No:58, Social Welfare (J), Dept., Dated: 12-5-1997)

III. Reservation of seats for women:

A (horizontal) reservation of 33 1/3 % of seats in favor of women candidates in each category (OC/SC/ST/BC/Special Categories) shall be followed.

The above reservation shall not be applicable if women candidates selected on merit in each category exceed 33 1/3%. If sufficient number of women candidates are not available in the respective categories those seats shall be diverted to the men candidates of the same category.

IV. Reservation for Special Categories:

(See Annexures - VI & VII)

- (a) Seats shall also be reserved for the following categories, to the extent indicated against them,
 - i. Physically Handicapped (PH) there shall be 3% (three percent) horizontal reservation in each category (OC, BC, SC, ST) for Visually handicapped/hearing impaired/ Orthopedically Handicapped (each 1%) (One percent).
 - ii. Children of Armed Forces Personnel (CAP) -2% (two percent) for the children of armed persons i.e. Ex-Servicemen, Defense Personnel including the Children of Border Security Force and the Central Reserve Police Force residing in Andhra Pradesh for a minimum period of 5 years.
 - iii. National Cadet Corps (NCC) 1% (one percent) horizontal reservation for National Cadet Corps candidates.

 Sports and Games (SP) – ½% (half percent) horizontal reservation for sports and Games candidates.

If qualified candidates belonging to PH/CAP/NCC/SP/ Categories are not available, the left over seats shall be filled up with candidates of General Pool of the same local area.

Note: The candidates claiming reservation benefits under the above categories shall produce original documents in support of their claim to the Convener of Admissions and he shall be entitled to get them scrutinized/verified and also refer the original document of the candidates claiming reservation for scrutiny and confirmation, to the following authorities.

- (i) PH Director, Medical & Health Services, AP
- (ii) CAP Director, Sainik Welfare Board, A.P./Telangana
- (iii) NCC Director of NCC, Andhra Pradesh /Telangana
- (iv) Sports & Games Vice-Chairman and Managing Director, Sports Authority of A.P. (SAAP)/Telangana

The priorities in respect of the special categories mentioned above shall be in accordance with Government Orders issued from time to time.

Seats will be reserved, to the following categories in Admissions to Professional Courses:

1. Reservation in State-wide Universities (as per Presidential Order 371 Article D in consonance to Section 95 of the A.P. Reorganization Act, 2014 (Lr. No: 1959/TE/A2/2015-2, dated 29-04-2015):

The admissions to 85% of the total available seats shall be reserved for the Local Candidates (Osmania University area, TS) and the remaining 15% of the seats shall be un-reserved (these seats can be filled with both States Telangana and Andhra Pradesh students based on merit) as specified in the Presidential Order 371 Article D in consonance to Section 95 of the A.P. Reorganization Act, 2014.

(A) Local Areas Means:

i. The part of the State comprising the districts of Adilabad, Bhadradri Kothagudem, Hyderabad, Jagtial, Jangaon, Jayashankar Bhoopalpally, Jogulamba Gadwal, Kamareddy, Karimnagar, Khammam, Komaram Bheem Asifabad, Mahabubabad, Mahbubnagar, Mancherial, Medak, Medchal , Nagarkurnool, Nalgonda, Nirmal, Nizamabad, Peddapalli, Rajanna Sircilla, Ranga Reddy, Sangareddy, Siddipet , Suryapet, Vikarabad, Wanaparthy, Warangal (Rural), Warangal (Urban) and Yadadri Bhuvanagiri shall be regarded as the Local Area for the purpose of admission to the Osmania University, the Kakatiya University, Telangana University, Mahatma Gandhi University, Palamuru University and to any other educational institutions (other than a state-wide university or state-wide educational institution) which is subject to the control of the State Government and situated in that part.

(B). Local Candidate means:

- 1. A candidate for admission shall be regarded as a **Local Candidate** in relation to a local area (Osmaina University Area, Telangana State).
 - 1.1 If he/she has studied in an educational Institution or educational institutions in such local area for a period of not less than four consecutive academic years ending with the academic year in which he/she appeared or first appeared in the relevant qualifying examination, as the case may be, (see Annexure II) or
 - 1.2 Where, during the whole or any part of the four consecutive academic years ending with the academic year in which he/she appeared or, as the case may be, first appeared for the relevant qualifying examination, he/she has not studied in

- (c) Candidates who are children of parents who are in the employment of in Telangana and Andhra Pradesh States or Central Government, Public Sector Corporations, Local Bodies, Universities and other similar quasi-public institutions, within the state, at the time of submitting the application (see Annexure IV) or
- (d) Candidates who are spouses of those in the employment of the state or Central Government, Public Corporations, Local Bodies, Universities and Educational Institutions recognized by the Government or University OR other competent authority and similar quasi Government Institutions within in Telangana and Andhra Pradesh States, at the time of submitting the application (see Annexure IV).
- 3. If a local candidate in respect of a local area is not available to fill any seat reserved or allocated in favour of a local candidate in respect of that local area, such seat shall be filled if it had not been reserved.
- 4. Candidates who claim reservation under any of the categories mentioned above shall enclose copies of relevant certificates. The respective proformas are available in the Annexure -2.

NOTE: For details, see the Andhra Pradesh Educational Institutions (Regulations of Admission) Order, 1974 as subsequently amended (G.O.No.646. dated 10.7.1979).

2. Reservation for SC/ST/BC Communities:

(See Annexure - V)

- (a) 15% of seats shall be reserved for the candidates belonging to scheduled Castes.
- (b) 6% of seats shall be reserved for the candidates belonging to the scheduled Tribes.

The seats reserved for scheduled Tribes shall be made available to scheduled Castes and Vice-versa, if qualified candidates are not available in the category. If qualified candidate belonging to Scheduled Castes and Scheduled Tribes communities are not available the left over seats reserved for them shall be treated as unreserved seats and shall be filled by candidates of General Pool.

(c) 25% of seats shall be reserved for the candidates belonging to the Backward Classes and shall be allocated among the following groups of Backward Classes as shown below:

If qualified candidates belonging to Backward Class of a particular group are not available, the leftover seats can be adjusted for the candidates of next group. If qualified candidates belonging to Backward Classes are not available to fill up the 25% seats reserved for them, the left over seats shall be treated as unreserved and shall be filled up with candidates of General Pool.

No candidates seeking reservation for admission under above categories be allowed to participate, in the Counseling for admission unless he/she produces the integrated Community Certificate prescribed by the Govt. and issued by the Revenue Authorities in the Government (vide G.O. MS. No: 58, Social Welfare (J), Dept., Dated: 12-5-1997)

III. Reservation of seats for women:

A (horizontal) reservation of 33 1/3 % of seats in favor of women candidates in each category (OC/SC/ST/BC/Special Categories) shall be followed.

The above reservation shall not be applicable if women candidates selected on merit in each category exceed 33 1/3%. If sufficient number of women candidates are not available in the respective categories those seats shall be diverted to the men candidates of the same category.

IV. Reservation for Special Categories:

(See Annexures - VII & VIII)

- (a) Seats shall also be reserved for the following categories, to the extent indicated against them,
 - i. Physically Handicapped (PH) there shall be 3% (three percent) horizontal reservation in each category (OC, BC, SC, ST) for Visually handicapped/ hearing impaired/ Orthopedically Handicapped (each 1%) (One percent).
 - ii. Children of Armed Forces Personnel (CAP) -2% (two percent) for the children of armed persons i.e. Ex-Servicemen, Defense Personnel including the Children of Border Security Force and the Central Reserve Police Force residing in Telangana for a minimum period of 5 years.
 - iii. National Cadet Corps (NCC) 1% (one percent) horizontal reservation for National Cadet Corps candidates.
 - iv. Sports and Games (SP) $-\frac{1}{2}$ % (half percent) horizontal reservation for sports and Games candidates.

If qualified candidates belonging to PH/CAP/NCC/SP/ Categories are not available, the left over seats shall be filled up with candidates of General Pool of the same local area.

- notice board and website for students to easily access them to submit after duly filling in.
- f. Candidates must send the duly filled in applications as specified by registered post with acknowledgement thereto.
- g. The colleges shall consider the received applications and prepare a merit list in the descending order of the applicants.
- h. The Merit List must be displayed on the notice board as well as the website of the respective colleges for two weeks.
- i. It should be made available for the scrutiny of the Convener (Admissions), EAMCET- 2013.
- j. Admissions will also be as per the Merit List in the descending order of the applicants
- k. The colleges have to obtain ratification from the Competent Authority for all the admissions conducted under category-B seats
- Tultion fees shall be charged as prescribed by AFRC for category-B seats
