- B. Microsoft wishes to collaborate with Organization by facilitating the setup of a Microsoft Innovation Center at **Annamacharya Institute Of Technology And Sciences**, Piglipur, Blatasingaram, Hayat nagar, Ranga Reddy District, Hyderabad, Telangana 501512 (the "MIC").

The parties agree as follows:

AGREEMENT

4. **Microsoft Trademark License Grant and Restrictions.**
 - (a) Microsoft grants to Organization a non-exclusive, non-transferable, royalty-free license to use the Microsoft trademark solely as part of the Microsoft Innovation Center name in its entirety and the Microsoft corporate logo as part of the Microsoft Innovation Center Logo lock up ("MIC Marks") as shown in Exhibit D hereto only during the term of this Agreement and in the territory of the MIC that meets (i) all



terms of this trademark license and Agreement, (ii) meets or exceeds standards of quality and performance of similar facilities generally accepted in the industry, and (iii) complies with all applicable laws, rules and regulations (collectively the "Quality Standards") and other conditions herein. The MIC Marks may solely be used on signage to identify the MIC as a Microsoft Innovation Center and advertising and promotional materials for the MIC as pre-approved by Microsoft in accordance with Section 5(a). Any Internet advertising or web marketing must be targeted to countries in the MIC territory. Microsoft reserves all rights not expressly granted herein.

- (b) Organization may not:
- (i) Sublicense the rights granted in Section 4(a) to any third party without Microsoft's prior written consent;
 - (ii) Do or say anything that implies Microsoft is affiliated with, sponsors, endorses, or approves of Organization other than as allowed by this Agreement;
 - (iii) Do or say anything that may cause confusion about whether Microsoft owns the MIC Marks or any Microsoft trademark in the MIC Marks;
 - (iv) Register, adopt, or use any name, trademark, domain name or other designation that includes or violates Microsoft rights in the MIC Marks or any Microsoft trademark in the MIC Marks;

- (d) Organization will take reasonable steps to notify Microsoft if Organization becomes aware of any suspected violation of or challenge to Microsoft's rights in the MIC Marks. Microsoft will determine, in its sole discretion, whether to take legal action to enforce or defend its rights in the MIC Marks and will control any legal action concerning the MIC Marks. Organization has no right to take legal action against third parties to enforce the rights it has in the MIC Marks under this Agreement.
- (e) Organization must use the ™ and ® symbols used in the MIC Marks, as shown on Exhibit D.
- (f) Organization must display the following trademark notice on all materials where the MIC Marks are used. "*Microsoft is a registered trademark of the Microsoft group of companies*".
- (g) Organization will cooperate with Microsoft to enable Microsoft to review Organization's use of the MIC Marks and ensure that the MIC complies with the Quality Standards. Organization will promptly correct any improper use of the MIC Marks and any MIC that does not comply with the Quality Standards upon reasonable notice from Microsoft.

6. Advertising.

- (a) Prior Approval of Advertising. Organization shall submit to Microsoft for its prior approval all advertising and promotional materials for the MIC ("**Advertising**"; the promulgation of such materials, to "**Advertise**") which use the MIC Marks or otherwise reference Microsoft. Microsoft shall endeavour to provide its approval or disapproval within fifteen (15) days of receiving the Advertising. Once Microsoft's consent has been obtained, Organization may produce the identical materials or substantially identical materials on future occasions without seeking any further consent from Microsoft, unless otherwise advised by Microsoft.
- (b) Microsoft Advertising. Microsoft may Advertise the MIC without the approval of the Organization.
- (c) Joint Advertising. The parties may agree to jointly Advertise the MIC, in which case both parties will provide their prior consent (each in their discretion) to the Advertising materials and methods used.
- (d) Correction of Errors. Upon discovery by either party of any errors in Advertising prepared by Organization, Organization shall (at its own expense) promptly correct or shall cause to be corrected any such errors.

7. Employment.

- (a) Organization Employees. Organization employees may be requested to perform administrative duties at the MIC as described in Exhibit B and as the parties



mutually determine. Organization will recruit, select and train its employees and will use persons qualified to perform the services and duties described in Exhibit B. Under no circumstances will any Organization employees be considered or be held out to be Microsoft employees. Organization will be solely responsible for supervising and directing all aspects of the work performed at the MIC by Organization employees and for compensating Organization employees for their work. Organization assumes sole responsibility for any and all employment-related liabilities with respect to Organization employees. Organization personnel involved with the MIC shall comply with all policies and/or procedures relating to the MIC as may be reasonably requested by Microsoft from time to time during the term of this Agreement. At Microsoft's good faith request for any business reason, Organization will promptly remove or replace any individual performing work at the MIC.

- (b) Safe Work Environment. Organization will provide a safe working environment for all Microsoft employees and agrees to comply with all applicable laws governing workplace safety.

8. **Facilities.**

- (a) Exclusive Use; Activities. During the term of this Agreement, Organization will provide facilities of a mutually agreed upon size and location to be used exclusively for the MIC (the "MIC Facilities"). Except as set forth in this Agreement, all substantive activities at the MIC, including but not limited to the content of any and all technical, business and marketing activities, training, and events, at the MIC, will be subject to Microsoft's standards, requirements and approval, and to the extent Organization personnel participate in such activities, Organization will ensure the work of such personnel meets Microsoft's standards and requirements for such activities, with Organization remaining solely responsible for determining the manner in which its personnel meet such standards and requirements.
- (b) Utilities. Organization is responsible for providing basic utilities (electricity, heat, water, internet connectivity) to the MIC Facilities, at Organization's cost, unless otherwise stated in this Agreement or in the Exhibits.
- (c) Safety. Organization will ensure that the MIC Facilities are safe and for all Organization employees, Microsoft employees and visitors.

9. **Organization Warranties.** Organization warrants, represents and covenants that:

- (a) it will comply with all applicable laws, rules and regulations;
- (b) it has the right, capacity and authority to enter into this Agreement;
- (c) this Agreement does not conflict with any other agreements or obligations by which it is bound;



- (d) all of its promotional, advertising and marketing material in connection with the MIC shall comply with all applicable laws and shall not infringe or otherwise breach the rights of any third parties in any applicable jurisdiction;
- (e) it is aware of and will comply with all laws relating to anti-bribery and corruption including but not limited to Foreign Corrupt Practices Act and the Indian Prevention of Corruption Act 1988
- (f) it will not (i) facilitate or promote any illegal, offensive or discriminatory activity or (ii) intentionally disparage the products, services or business of Microsoft or any of its affiliates (including Microsoft Corporation), or otherwise act in a manner that is detrimental to or reflects unfavourably on the name or business reputation of Microsoft or any of its affiliates, at or in connection with the MIC; and
- (g) there is no proceeding in progress or pending or threatened against, relating to or affecting it which might be expected to have a materially adverse effect on the performance of its obligations under this Agreement, or on the business or reputation of Microsoft or any of its affiliates.

10. **Microsoft Warranties.**

- (a) Microsoft warrants that it has the right, capacity and authority to enter into this Agreement.
- (b) EXCEPT FOR THOSE WARRANTIES EXPRESSLY PROVIDED IN THIS SECTION 10, MICROSOFT DISCLAIMS ALL WARRANTIES, EXPRESS, IMPLIED OR STATUTORY, AS TO ANY MATTER WHATSOEVER RELATING TO THIS AGREEMENT, INCLUDING WITH RESPECT TO ANY MATERIALS, SOFTWARE, AND HARDWARE (IF ANY) PROVIDED UNDER SECTION 1 OF THIS AGREEMENT AND ANY OTHER INFORMATION OR MATERIALS, INCLUDING ANY TRADEMARKS AND THE MIC MARKS PROVIDED BY MICROSOFT UNDER THE TERMS OF THIS AGREEMENT, INCLUDING BUT NOT LIMITED TO ANY (IF ANY) IMPLIED WARRANTIES OR CONDITIONS OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, REASONABLE CARE OR WORKMANLIKE EFFORT, RESULTS, LACK OF NEGLIGENCE, TITLE OR NON-INFRINGEMENT, LACK OF VIRUSES, OR OF ACCURACY OR COMPLETENESS OF RESPONSES.

11. **Indemnity.**

- (a) Organization agrees to indemnify, defend and hold harmless Microsoft and its affiliates and each of their respective directors, officers, agents, contractors and employees from any and all actions, claims, demands, complaints, orders, costs, liabilities, expenses and damages ("Claims"), including reasonable legal fees and expenses, arising out of or relating to (1) the failure of Organization, its employees and/or agents to comply with any terms and conditions of this Agreement; (2) any personal injury, workman's compensation or property damage claim of any individual related in any way to the MIC Facilities; (3) the negligent or intentional



acts or omissions of Organization, its employees and/or agents, except to the extent that such a Claim arises as a result of Microsoft's negligence or wilful misconduct, (4) Organization's use of the MIC Marks in breach of this Agreement.

- (b) Microsoft agrees to indemnify, defend and hold harmless Organization and its affiliates and each of their respective directors, officers, agents, contractors and employees from any third-party claims, damages, costs, expenses and reasonable attorneys' fees alleging that the MIC Marks or any Microsoft trademark contained in the MIC Marks infringes any trademark rights of such third party in the territory of the MIC.
 - (c) The indemnity set forth in this Section 11 shall survive and shall be enforceable beyond the termination or expiration of this Agreement.
12. **LIMITATIONS OF LIABILITY.** IN NO EVENT SHALL EITHER PARTY BE LIABLE TO THE OTHER PARTY FOR ANY INDIRECT, SPECIAL, PUNITIVE, INCIDENTAL OR CONSEQUENTIAL DAMAGES WHATSOEVER (INCLUDING, WITHOUT LIMITATION, DAMAGES FOR LOSS OF BUSINESS PROFITS, BUSINESS INTERRUPTION, LOSS OF BUSINESS INFORMATION, OR ANY OTHER PECUNIARY LOSS) ARISING OUT OF, RESULTING FROM OR RELATED TO THE MIC OR TO THIS AGREEMENT, EVEN IF A PARTY HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. NOTWITHSTANDING THE FOREGOING, THIS SECTION SHALL NOT APPLY TO INDEMNIFICATION OBLIGATIONS, ANY INFRINGEMENT OF INTELLECTUAL PROPERTY RIGHTS BY THE OTHER PARTY OR ANY BREACH OF THE CONFIDENTIALITY OBLIGATIONS SET OUT IN THIS AGREEMENT.
13. **Confidentiality.** The terms of the Microsoft standard nondisclosure agreement between the parties shall govern the use and protection of confidential information under this Agreement. The terms of this Agreement shall be considered confidential information under such agreement.
14. **Personal Information.** Organization represents and warrants that the collection, use, disclosure and storage of any Personal Information in connection with this Agreement or the MIC, including the disclosure of personal information to Microsoft, shall be in full compliance with all applicable laws including, without limitation, data protection and privacy laws. Organization further represents and warrants that all necessary notices and consents shall be given or obtained to allow Microsoft to receive and use the Personal Information to be provided to Microsoft pursuant to this Agreement and that Microsoft shall be free to use such information for the purposes of (i) the MIC, (ii) to inform the individuals of products or services offered by Microsoft and its affiliates, and (iii) to send individuals relevant survey invitations related to products or services offered by Microsoft or its affiliates. For the purpose of this Agreement, "Personal Information" means any information about an identifiable individual or information which relates to a natural person and allows that person to be identified.



15. **Taxes.** The parties are not liable for any of the taxes of the other party that the other party is legally obligated to pay and which are incurred or arise in connection with or related to the transactions contemplated under this Agreement, and all such taxes (including but not limited to net income or gross receipts taxes, franchise taxes, sales and use taxes, and/or property taxes) shall be the financial responsibility of the party who is obligated by operation of law to pay such tax. Each party agrees to indemnify, defend and hold the other party harmless from any taxes or claims, causes of action, costs (including, without limitation, reasonable attorneys' fees) and any other liabilities of any nature whatsoever related to a party's taxes.

16. **Term and Termination.**

- (a) Term. This Agreement shall commence on the Effective Date and stay in full force and effect for a period of one year unless earlier terminated pursuant to other provisions of this Agreement.
- (b) Termination By Either Party For Cause. Either party may suspend performance and/or terminate this Agreement immediately upon written notice at any time if the other party is in breach of any warranty, term, condition or covenant of this Agreement and fails to cure that breach within thirty (30) days after written notice thereof.
- (c) Immediate Termination. Microsoft may terminate this Agreement immediately upon written notice in the event that Organization or its representatives engage in any activities that, in the reasonable opinion of Microsoft, would pose a risk to Microsoft's reputation or goodwill as a result of its continued association with Organization or the MIC. In addition, Microsoft may terminate this Agreement immediately upon notice in the event that the Organization (a) becomes insolvent; (b) admits in writing its inability to pay its debts as they become due; (c) makes an assignment for the benefit of creditors; or (d) if a petition under any bankruptcy statute, receivership statute, or similar statute, as they now exist or as they may be amended, is filed by the other party or by any third party or an application for a receiver is made by anyone and such application is not resolved favourably to the other party within sixty (60) days.
- (d) Obligations Upon Termination. In the event that this Agreement is terminated pursuant to this Section 16, Microsoft shall close the MIC and all software use and trademark use rights related to the MIC, if any, shall terminate. Microsoft will retain ownership of all software, hardware, equipment (as recorded under Exhibit C), content and materials in the MIC. Organization acknowledges and agrees that Microsoft's remedies under this Section 16 are in addition to, and not in lieu of, any other rights or remedies that it may have at law or in equity.
- (e) Survival. Sections 3, 9, 10, 11, 12, 13, 14, 15, 16 and 17, shall survive termination of this Agreement.



17. **General.**

(a) **Force Majeure.** Any delay or failure of either party to perform its obligations hereunder shall be excused to the extent that it is caused by an event or occurrence beyond its reasonable control such as, by way of example and not by way of limitation, acts of God, actions by governmental authority (whether valid or invalid), fires, floods, windstorms, explosions, riots, natural disasters, wars, sabotage or labour problems; provided the party claiming force majeure promptly notifies the other party of the event of force majeure, the anticipated duration of the event of force majeure, and the steps being taken to remedy the failure. Should the event of force majeure continue beyond fifteen (15) days or such shorter time period as may be reasonable under the circumstances, either party may terminate this Agreement, and Organization shall refund any portion of Sponsorship Fee already paid by Microsoft, if any, corresponding to the proportion of the benefits under this Agreement not yet received by Microsoft as a result of such termination.

(b) **Notices.** All notices and requests in connection with this Agreement shall be in writing and may be sent either by registered mail, facsimile transmission or personal delivery, to the following addresses:

Any such notice, in the case of facsimile transmission or personal delivery, shall be deemed to have been received and shall be effective on the date of delivery and, in the case of registered mail, shall be deemed to have been received and shall be effective on the fifth (5th) day following the date on which it is mailed.

(c) **Insurance.** Organization shall procure and maintain at its own expense insurance coverage of at least **zero Rupees** for its obligations hereunder and shall provide proof of such insurance to Microsoft upon request. Insurance clause is not applicable for MIC at **Annamacharya Institute Of Technology And Sciences,**

- (d) Independent Contractors. Microsoft and Organization are independent contracting parties, and nothing in this Agreement shall be construed as creating an employer-employee relationship, a partnership, a franchisee-franchisor relationship, or a joint venture between the parties. Organization is not an agent of Microsoft and has no authority to bind Microsoft by its acts or agreements.

- (e) Governing Law.

This Agreement shall be governed by and construed in accordance with the laws of India. Any dispute arising out of the Agreement shall be referred to arbitration under the Arbitration & Conciliation Act, 1996. The arbitral tribunal shall consist of three arbitrators - one each to be appointed by Microsoft and Organization and the two appointed arbitrators then appointing an umpire. The venue of arbitration shall be New Delhi. The decision of the arbitrator shall be final, binding and incontestable and may be used as a basis for judgment thereon in India or elsewhere. This choice of jurisdiction and venue does not prevent either party from seeking injunctive relief with respect to a violation of intellectual property rights or enforcement or recognition of any award or order in any appropriate jurisdiction.

- (f) Assignment. This Agreement shall be binding upon and inure to the benefit of each party's respective successors and lawful assigns; provided, however, that Organization may not assign this Agreement, in whole or in part, without the prior written approval of Microsoft at Microsoft's sole discretion. For greater certainty, Microsoft may assign this Agreement at any time to an affiliate.

- (g) Construction. If for any reason a court of competent jurisdiction finds any provision of this Agreement, or portion thereof, to be invalid or unenforceable, such invalidity or unenforceability shall not affect the validity or enforceability of any other provision of this Agreement (or portion thereof) and any such invalid or unenforceable provision shall be deemed to be severable. Failure by either party to enforce any provision of this Agreement shall not be deemed a waiver of future enforcement of that or any other provision. This Agreement has been negotiated by the parties and their respective counsel and will be interpreted fairly in accordance with its terms and without any strict construction in favour of or against either party.

- (h) Entire Agreement. This Agreement does not constitute an offer by Microsoft and it shall not be effective until signed by both parties. This Agreement and the documents referenced herein constitute the entire agreement between the parties with respect to the subject matter hereof and merges all prior and contemporaneous communications. It shall not be modified except by a written agreement dated subsequent to the date of this Agreement and signed on behalf of Organization and Microsoft by their respective duly authorized representatives.
